The excess applies per insured person per insured year. If the period insured is shorter than a year, then the excess applies for the period insured. This health insurance coverage is **not** subjected to insurance taxes.

If you take out this insurance alongside Dutch basic health insurance, you will receive 15% discount on the premium for as long as you are actually insured with the Dutch basic health insurance.
